Trustees' Report 2018/2019

Trustees of the Ranaviru Fund have the pleasure of producing this report for the Financial Year 2018-2019.

A total of £5,274 carried forward from the financial year 2017/2018. A total of £3,991 received as donations, refunds and bank interest during this financial year. During the financial year the Charity has donated £5,586 for charitable activities.

During the month of May 2018, the Charity has donated £1,289.92 to an appeal raised by a retired service personnel of the Sri Lanka Army, whose only daughter was undergoing a Bone Marrow Transplant, who she suffers from a rare blood cancer. This is the second donation made by the Charity towards treatment of this young adult as part of Charity's pledge during the last financial year. The recent medical reports of the patient indicate that she has successfully undergone the surgery and the treatments received. The funds were transferred to the hospital she was treated as a direct payment towards her bills. The Charity has partnered with one of Sri Lanka's longest standing Charities to build a house for the bereaved family of a Sri Lanka Army personnel. The charity was able to raise a significant amount of funds within a short time period and these funds were then provided to the local Charity, the Shanthi Foundation. Funds were originally transferred via a registered and regulated money transfer service, 'Fast Cash'. However, due to some incorrect instructions from Charity's end, the said money transfer was not successful and the Charity was at losing some funds. Then the Charity has signed an agreement with another registered and regulated money transfer service, EzCash. EzCash has offered a significantly low transaction fee and a better exchange rate to the charity. Charity has requested to refund the original sum transferred to Fast Cash subject to a charge of £8 as a transaction fee. A total of £3,017.25 was refunded to Charity's bank account after the £8 fee was taken. This amount of funds was recorded as a 'Refund' to the Charity. In the meantime, the Charity has sent £2,976.11 on 14th March 2019 to Shanthi Foundation via EzCash, the transaction shows in the image below.
