Objectives, organisation and activities:

Ranaviru Fund is an unincorporated association concerned with the relief of those in need by reason of age, ill health, disability, financial hardship or other disadvantage people in the community. It is a registered charity, number SC041479.

The objectives of the charity are:

To provide medical, rehabilitation, welfare and social assistance for the fallen, missing, disabled and wounded Army, Navy, Air Force, Police and Civil Defence Forces members (hereinafter referred as the "Soldier" or "Soldiers") and their immediate family members in Sri Lanka.

It makes grants, donations, loans, gifts or pensions to individuals and to organisations.

Trustees of the Ranaviru Fund have the pleasure of producing this report for the Financial Year 2022-2023.

A total of £5,752 carried forward from the financial year 2021-2022.

A total of £5,173 received as donations during the FY 2022/23 with no bank interest received during this financial year.

During the financial year the charity has invested £4,612 in charitable activities while £60 spent on subscriptions and professional fees.

At the end of the financial year 2022/23 a total of £6,253 retained in the charity's bank account.

Every possible measure has been taken by the Trustees of the charity to minimise the administrative costs and other operational costs of the charity to a minimum.

### Details of Activities

#### 2022 June: Food Donation to Thanthirimale Village

It was the time of Sri Lanka's financial meltdown and we were approached by our charity coordinators on the ground with news of daring needs of a local village in Anuradhapura district in northern Sri Lanka. Ranaviru Fund has funded a small project to donate dry food rations to 50 needy families in the village. This was coordinated by the local Temple and the food rations were bought from the local CO-OP society who also packed and delivered the food parcels to the local Temple for distribution.

The total cost of this project was LKR 250,000.00, equivalent to £550.86.



## 2022 June: Medical Supplies to Lady Ridgeway Hospital for Children

Sri Lanka was going through some serious financial difficulties during 2022 and as a result the local hospitals had serious shortage of essential medicines. Country's biggest hospital for children, the Lady Ridgeway Hospital for Children has reached out to the charity requesting donations for essential medicines for the urgent care of the sick children.

Ranaviru Fund has funded a project to deliver 105 units of one of the essential medicines requested by the hospital. A total of LKR 700,000, equivalent to £1,585.14 spent from the reserves.



